Entry Fee: \$150 (6-8 & 9-11 9-Hole Age Divisions: \$75)

ELIGIBILITY

Entries are open to any male or female amateur golfer who is a legal resident of Alabama, has an active GHIN® USGA Handicap Index® at an AGA member club and qualifies under the following age requirements:

- **14-18 Age Division:** Must have reached 14th birthday, but not 19th birthday, on or before November 9, 2024.
- **9-13 Age Division:** Must have reached 9th birthday, but not 14th birthday, on or before November 9, 2024.
- **6-8 Age Division:** Must have reached 6th birthday, but not 9th birthday, on or before November 9, 2024.

Note: Entrant can apply for an exemption into an older age division or remain in a younger age division (if they already played in a younger division this season) by contacting Karl Yervey, Manager of Junior Golf and Tournaments at karl@alabamagolf.org.

Entries are subject to rejection or withdraw at any time, including during the event, by the JGA or the host club. The reason for rejection may include unbecoming conduct during a stipulated round. All players must conform to the "USGA Rules of Amateur Status" as specified in "The Rules of Golf." For complete residency and eligibility requirements, refer to the [JGA Tournament Manual](#).

ENTRIES AND ONLINE REGISTRATION

Entry is limited to the first **84** players. If the tournament is full at the time of registration, a player may opt to be placed on the alternate wait list. Wait list alternates are ranked according to date/time an entry is received and processed.

- Boys 14-18: 30 Players
- Boys 9-13: 18 Players
- Boys 6-8 or Boys 9-11 9-Hole Divisions: 9 Players
- Girls 14-18: 12 Players
- Girls 9-13: 9 Players
- Girls 6-8 or Girls 9-11 9-Hole Divisions: 6 Players

All players must register online at www.juniorgolfalabama.org. Fax, mail-in, or telephone applications are not accepted.

- **All entries must be RECEIVED in the JGA office no later than 11:59pm, Tuesday, October 29, 2024. No entries will be accepted after that time.**
- An entry fee in the amount of \$150.00 (\$75.00 for 6-8 & 9-11 9-Hole Age Divisions), payable by **credit card**, must accompany the entry application, \$5.00 of which will be donated to the Alabama Turfgrass Research Foundation.
- Upon successfully completing the entry procedure, an email confirmation will be automatically generated and sent to you at the email address you designated.

The JGA is not responsible for errors or delays by any internet service provider. Entries are only accepted between the open and close dates as stated above. Confirmation of acceptance is sent to players when their status is determined. Status may be checked at www.juniorgolfalabama.org. The appropriate entry fee must be paid by each player at the time of registration.

Please be advised that all online entry applications for players who are minors, upon date of submission, in the state in which they reside (e.g. Alabama/Florida, under the age of 18) must be submitted by a parent/guardian, must list the parent/guardian's name, phone number, and e-mail address. The parent/guardian agrees to be bound by all the terms and conditions on their own behalf and on behalf of the minor player. The JGA reserves the right to require submission of an original signature of the parent/guardian in a confirmation copy of the application upon notification by the AGA to the parent/guardian.

REFUND POLICY

Withdrawal: If an accepted player withdraws for any reason before the close of registration at **11:59pm on Tuesday, October 29, 2024**, the entry fee will be refunded, subject to a \$30.00 service fee. If an accepted player withdraws for any reason after the close of registration and before **11:59pm on Thursday, November 7, 2024**, 75% of the entry fee will be refunded. No refunds will be made for withdrawals after that time.

No Shows: Players that fail to notify the JGA of their withdrawal and “No Show” their starting time will not receive a refund for any reason. “No Show” players may be subject to suspension from future JGA events.

Alternates: Full refund if a player does not gain entry to the tournament.

*All dates and time refer to **date and time of receipt** at the JGA office.

AJGA ACE GRANT PROGRAM

ACE Grant Reimbursements for JGA Tour Tournaments (\$250 max)

1. Junior must be/become an AJGA member
 - a. \$215 cost but the ACE Grant will automatically reimburse \$165, so out-of-pocket is \$50
 - b. Once an ACE Grant recipient the junior will be upgraded to a Junior Plus membership for no additional cost

2. Must apply for and receive the ACE Grant (any applicant that is denied will receive a full refund, if the junior has not applied to any event before they were denied)
3. Reimbursement can be received for the following according to the AJGA Maximum allowances found [here](#) under reimbursement levels, if itemized receipts are presented:
 - a. Tournament Entry Fee
 - b. Travel
 - c. Housing
 - d. Food and beverage
4. All reimbursements are retroactive, meaning even if the event has already happened you can still apply, receive the grant and reimbursement if you still have the appropriate receipts.

TOURNAMENT FORMAT

- 36 holes of gross individual stroke play for players in the age 9-11, 12-13 & 14-18 18-hole divisions.
- 18 holes (9 each day) for players in 9-Hole divisions.
- The lowest score for 36 holes in each division (9-11, 12-13 and 14-18 18-Hole Age Divisions) will be the divisional champion.
- Ties in all divisions will be resolved by matching scorecards according to the USGA recommendation within the Committee Procedures of the Rules of Golf – “Matching Scorecards”
- Initial groupings will be for Round 1. Players will be re-paired by score for Final Round.

TOURNAMENT SCHEDULE

Practice Round:

Wednesday, November 6, 2024 (may call to reserve a time on Saturday, November 2, 2024)

Thursday, November 7, 2024 (may call to reserve a time on Sunday, November 3, 2024)

*Players are limited to one (1) practice round and may arrive no more than 45-minutes prior to their time and must depart immediately afterwards. The Pro Shop will pair JGA players with registered play, as needed.

Saturday, November 9, 2024

First round of individual stroke play.

*Players may arrive no more than 45-minutes prior to their time and must depart immediately afterwards.

Sunday, November 10, 2024

Final round of individual stroke play.

*Players may arrive no more than 45-minutes prior to their time and must depart immediately afterwards.

RANGE FEES; PUSH CARTS

- *Practice Rounds:* Practice round fee is not included in the entry fee.
- *Tournament Site:* All range fees during the tournament rounds are paid by the JGA and are included in the entry fee. Competitors must walk during tournament rounds. Push carts are allowed.

CADDIES

- *Caddies:* Caddies are not allowed, except in the 6-8 and 9-11 9-Hole Age Divisions.
- *Parents/Guardians are allowed to caddie for the 6-8 and 9-11 9-Hole Age Divisions only and must walk.*

SPECTATORS

- *Spectator Cart Policy*: Host club policy allows spectator carts only to those with a state-issued Handicap placard.
- *Disability Golf Cart Policy*: In consistency with the Americans with Disabilities Act (ADA), JGA will grant an individual with a bona fide disability a golf cart if the following conditions are met:
 - Requesting individual completes and submits a [Disabled Golf Cart Request Form](#) by the close of entry date.
 - The host club has a golf cart available.
 - Requesting individual pays host club, the appropriate fee.
 - Requesting individual presents to the JGA staff or JGA representative a disability card issued by a government agency.
- Non-club owned spectator carts are not allowed except as provided in the [JGA Tournament Manual](#).

PRIZES & AWARDS

Awards will be presented as follows:

- Top 3 in Male Age Divisions: 6-8, 9-11 (9-hole), 9-11 (18-hole), 12-13, 14-18 Age Divisions
- Top 3 in Female Age Divisions: 6-8, 9-11 (9-hole), 9-11 (18-hole), 12-13, 14-18 Age Divisions

RULES OF GOLF; CLOSE OF COMPETITION; SPECIAL REQUESTS

USGA Rules of Golf govern play. Questions will be decided by the on-site Rules Committee whose decision will be final. Notice to Players and local rules are posted at host club and distributed at the starting tee(s). The JGA reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the tournament. The competition is closed when the tournament trophies have been presented. Special requests for starting times or pairings may not be granted.

CONDITIONS AGREEMENT

- I agree that the JGA Tour has the right to reject, or withdraw, any entry at any time.
- I am an amateur golfer, and I understand the "Rules of Amateur Status" as established by the United States Golf Association.
